I, the undersigned Releasor, being of lawful age, in consideration of being permitted to participate in any shooting sports activities at the CADILLAC SPORTSMAN'S CLUB, INC, or any other place where such activities may be conducted, do for myself, my spouse, legal representatives, heirs, and assigns hereby release, waive, and forever discharge the STATE OF MICHIGAN and the CADILLAC SPORTSMAN'S CLUB, INC, its agencies or departments, its officers, agents, service members, and employees in their official and personal capacities, their heirs, administrators, and executors, from any and all liability for any and all loss or damage, and from any and every claim, demand, action, or right of action, of whatever kind of nature, either in law or equity, arising from or by reason of death, or any bodily injury or personal injuries known or unknown, or property damage resulting or to result from any incident, which may occur during my participation in any shooting sports activities, or any activities in connection with any shooting sports activities, whether caused in whole or in part by the Releasees, or otherwise.

I HEREBY ASSUME FULL RESPONSIBILITY FOR THE RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE DUE TO THE NEGLIGENCE OF RELEASEES, OR OTHERWISE WHILE AT CADILLAC SPORTSMAN'S CLUB, INC, OR AT ANY OTHER PLACE WHERE SUCH SHOOTING SPORTS ACTIVITIES MAY BE CONDUCTED, AND WHILE COMPETING, OFFICIATING, WORKING, SPECTATING, OR FOR ANY PURPOSE PARTICIPATING IN THE CADILLAC SPORTSMAN CLUB'S, INC, SHOOTING SPORTS ACTIVITIES.

I AGREE THAT THIS RELEASE CONSTITUTES THE ENTIRE AGREEMENT BETWEEN MYSELF AND THE STATE OF MICHIGAN AND THE CADILLAC SPORTSMAN'S CLUB, INC, AND THE TERMS OF THIS RELEASE ARE CONTRACTUAL AND NOT A MERE RECITAL, AND THE SAME SHALL CONTINUE IN FORCE AND BE APPLICABLE TO ALL SHOOTING SPORTS ACTIVITIES I ATTEND, WHICH ARE CONDUCTED BY THE CADILLAC SPORTSMAN'S CLUB, INC, UNLESS REVOKED BY ME IN A WRITING SERVED UPON THE CADILLAC SPORTSMAN'S CLUB, INC, BY CERTIFIED MAIL AT LEAST TEN (10) DAYS PRIOR TO THE DATE UPON WHICH SUCH REVOCATION SHALL BECOME EFFECTIVE.

I agree that this Release Agreement is intended to be as broad and inclusive as permitted by law, and that if any portion hereof is held invalid, the balance hereof will, notwithstanding, continue in full legal force and effect.
